




Figure 1. DC Current Gain




Figure 2. Collector-Emitter Saturation Voltage and Base-Emitter Saturation Voltage




Figure 3. Collector-Base Capacitance




Figure 4. Current Gain Bandwidth Product




Figure 5. 3-LEAD, SOT23, JEDEC TO-236, LOW PROFILE (ACTIVE)
