









DRAIN CURRENT vs. DRAIN TO SOURCE VOLTAGE




MINIMUM NOISE FIGURE, ASSOCIATED GAIN vs. FREQUENCY



RF MEASURING LAYOUT PATTERN (REFERENCE ONLY) (UNIT: mm)






(Top View)
