






Figure 1. DC Current Gain




Figure 2. Collector-Emitter Saturation Voltage




Figure 3. Input-On Voltage




Figure 4. Input-Off Voltage




Figure 5. Power Derating




Figure 6. 3-LEAD, SOT-23, JEDEC TO-236, LOW PROFILE (ACTIVE)
