Performance Curves

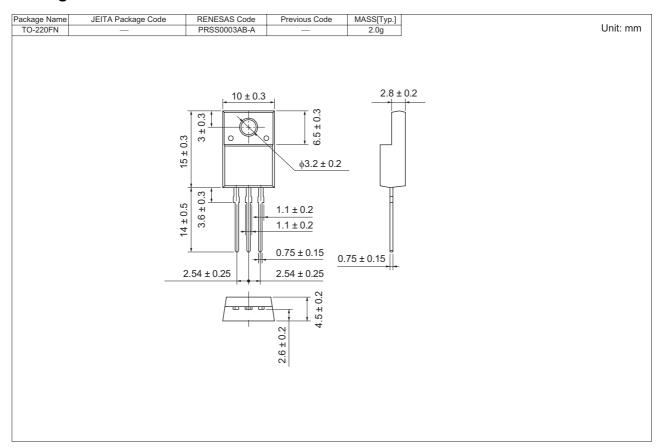
