# LP3869x-ADJ 1-A Low Dropout CMOS Linear Regulator With Adjustable Output Stable With Ceramic Output Capacitors

## 3 Description

The LP38690-ADJ and LP38692-ADJ low dropout CMOS linear regulators provide 2.5\% precision reference voltage, extremely low dropout voltage ( 450 mV at 1-A load current, $\mathrm{V}_{\text {OUt }}=5 \mathrm{~V}$ ) and excellent AC performance utilizing ultralow equivalent series resistance (ESR) ceramic output capacitors.
The low thermal resistance of the WSON and SOT223 packages allow the full operating current to be used even in high ambient temperature environments.

The use of a PMOS power transistor means that no DC base drive current is required to bias it allowing ground pin current to remain below $100 \mu \mathrm{~A}$ regardless of load current, input voltage, or operating temperature.

- Dropout Voltage: 450 mV (typical) at 1 A (typical 5-V out)
- Ground Pin Current: $55 \mu \mathrm{~A}$ (typical) at full load
- Adjust Pin Voltage: $2.5 \%\left(25^{\circ} \mathrm{C}\right)$ accuracy

## 7 Detailed Description

### 7.1 Overview

The LP3869x-ADJ devices are designed to meet the requirements of portable, battery-powered digital systems providing an accurate output voltage with fast start-up. When disabled via a low logic signal at the enable pin (EN), the power consumption is reduced to virtually zero (LP38692-ADJ only). The LP3869x devices perform well with a single $1-\mu \mathrm{F}$ input capacitor and a single $1-\mu \mathrm{F}$ ceramic output capacitor.

### 7.3 Feature Description

### 7.3.1 Foldback Current Limiting

Foldback current limiting is built into the LP3869x-ADJ which reduces the amount of output current the part can deliver as the output voltage is reduced. The amount of load current is dependent on the differential voltage between $\mathrm{V}_{\text {IN }}$ and $\mathrm{V}_{\text {out }}$. Typically, when this differential voltage exceeds 5 V , the load current will limit at about 450 mA . When the $\mathrm{V}_{\text {IN }}-\mathrm{V}_{\text {OUT }}$ differential is reduced below 4 V , load current is limited to about 1500 mA .

## CAUTION

When toggling the LP38692 EN pin after the input voltage ( $\mathrm{V}_{\text {IN }}$ ) is applied, the foldback current limit circuitry is functional the first time that the EN pin is taken high. The foldback current limit circuitry is non-functional the second, and subsequent, times that the EN pin is taken high. Depending on the input and output capacitance values the input inrush current may be higher than expected which can cause the input voltage to droop.
If the EN pin is connected to the IN pin, the foldback current limit circuitry is functional when $\mathrm{V}_{\mathrm{IN}}$ is applied if $\mathrm{V}_{\text {IN }}$ starts from less than 0.4 V .

### 7.4 Device Functional Modes

### 7.4.1 Enable Pin (LP38692-ADJ Only)

The LP38692-ADJ has an enable pin (EN) which allows an external control signal to turn the regulator output on and off. The enable on/off threshold has no hysteresis. The voltage signal must rise and fall cleanly, and promptly, through the on and off voltage thresholds. The EN pin has no internal pull-up or pull-down to establish a default condition and, as a result, this pin must be terminated either actively or passively. If the EN pin is driven from a source that actively pulls high and low, the drive voltage must not be allowed to go below ground potential or higher than $\mathrm{V}_{\mathrm{IN}}$. If the application does not require the enable function, the pin must be connected directly to the IN pin.

## 8 Application and Implementation

## NOTE

Information in the following applications sections is not part of the TI component specification, and TI does not warrant its accuracy or completeness. TI's customers are responsible for determining suitability of components for their purposes. Customers should validate and test their design implementation to confirm system functionality.

### 8.1 Application Information

### 8.1.1 Reverse Voltage

A reverse voltage condition exists when the voltage at the OUT pin is higher than the voltage at the $\mathbb{I N}$ pin. Typically this happens when IN is abruptly taken low and $\mathrm{C}_{\text {OUT }}$ continues to hold a sufficient charge such that the input-to-output voltage becomes reversed. A less-common condition is when an alternate voltage source is connected to the output.
There are two possible paths for current to flow from the OUT pin back to the input during a reverse voltage condition.

1. While $\mathrm{V}_{\mathbb{I}}$ is high enough to keep the control circuity alive, and the EN pin (LP38692-ADJ only) is above the $\mathrm{V}_{\text {EN(ON }}$ threshold, the control circuitry will attempt to regulate the output voltage. If the input voltage is less than the programmed output voltage, the control circuit drives the gate of the pass element to the full ON condition. In this condition, reverse current flows from the OUT pin to the IN pin, limited only by the $\mathrm{R}_{\mathrm{DS}(\mathrm{ON})}$ of the pass element and the output to input voltage differential. Discharging an output capacitor up to $1000 \mu \mathrm{~F}$ in this manner does not damage the device as the current rapidly decays. However, continuous reverse current must be avoided. When the EN pin is low this condition is prevented.
2. The internal PFET pass element has an inherent parasitic diode. During normal operation, the input voltage is higher than the output voltage and the parasitic diode is reverse biased. However, when $\mathrm{V}_{\mathbb{I N}}$ is below the value where the control circuity is alive, or the EN pin is low (LP38692-ADJ only), and the output voltage is more than 500 mV (typical) above the input voltage the parasitic diode becomes forward biased and current flows from the OUT pin to the IN pin through the diode. The current in the parasitic diode must be limited to less than 1-A continuous and 5-A peak.

If used in a dual-supply system where the regulator output load is returned to a negative supply, the OUT pin must be diode clamped to ground to limit the negative voltage transition. A Schottky diode is recommended for this protective clamp.

### 8.2.1 Design Requirements

For typical CMOS voltage regulator applications, use the parameters listed in Table 1
Table 1. Design Parameters

| DESIGN PARAMETER | EXAMPLE VALUE |
| :---: | :---: |
| Minimum input voltage | 2.7 V |
| Minimum output voltage | 1.25 V |
| Output current | 150 mA |
| Input and output capacitors | $1 \mu \mathrm{~F}$ |
| Input/output capacitor ESR range | $0 \mathrm{~m} \Omega$ to $100 \mathrm{~m} \Omega$ |

### 8.2.2 Detailed Design Procedure

### 8.2.2.1 Setting The Output Voltage

The output voltage is set using the external resistors R1 and R2 (see Figure 29 and Figure 30). The output voltage is given by Equation 1:

$$
\begin{equation*}
V_{\text {OUT }}=V_{\text {ADJ }} \times(1+(R 1 / R 2)) \tag{1}
\end{equation*}
$$

Because the part has a minimum load current requirement of $100 \mu \mathrm{~A}$, TI recommends that R2 always be $12 \mathrm{k} \Omega$ or less to provide adequate loading. Even if a minimum load is always provided by other means, it is not recommended that very high value resistors be used for R1 and R2 because it can make the ADJ node susceptible to noise pickup. A maximum value of $100 \mathrm{k} \Omega$ is recommended for R 2 to prevent this from occurring.

### 8.2.2.2 External Capacitors

Like any low-dropout regulator, external capacitors are required to assure stability. These capacitors must be correctly selected for proper performance.

### 8.2.2.2.1 Input Capacitor

An input capacitor of at least $1 \mu \mathrm{~F}$ is required (ceramic recommended). The capacitor must be located not more than one centimeter from the IN pin and returned to a clean analog ground.

### 8.2.2.2.2 Output Capacitor

An output capacitor is required for loop stability. It must be located less than 1 centimeter from the device and connected directly to the OUT and GND pins using traces which have no other currents flowing through them.
The minimum amount of output capacitance that can be used for stable operation is $1 \mu \mathrm{~F}$. Ceramic capacitors are recommended (the LP3869x-ADJ was designed for use with ultralow-ESR capacitors). The LP3869x-ADJ is stable with any output capacitor ESR between $0 \Omega$ and $100 \Omega$.

### 8.2.2.2.3 Selecting A Capacitor

It is important to note that capacitance tolerance and variation with temperature must be taken into consideration when selecting a capacitor so that the minimum required amount of capacitance is provided over the full operating temperature range.

### 8.2.2.2.3.1 Ceramic

For values of capacitance in the $10-\mu \mathrm{F}$ to $100-\mu \mathrm{F}$ range, ceramics are usually larger and more costly than tantalum capacitors but give superior AC performance for bypassing high frequency noise because of very low ESR (typically less than $10 \mathrm{~m} \Omega$ ). However, some dielectric types do not have good capacitance characteristics as a function of voltage and temperature.
Z5U and Y5V dielectric ceramics have capacitance that drops severely with applied voltage. A typical Z5U or Y 5 V capacitor can lose $60 \%$ of its rated capacitance with half of the rated voltage applied to it. The $\mathrm{Z5U}$ and Y 5 V also exhibit a severe temperature effect, losing more than $50 \%$ of nominal capacitance at high and low limits of the temperature range.
X7R and X5R dielectric ceramic capacitors are strongly recommended if ceramics are used, as they typically maintain a capacitance range within $\pm 20 \%$ of nominal over full operating ratings of temperature and voltage. They are typically larger and more costly than $\mathrm{Z} 5 \mathrm{U} / \mathrm{Y} 5 \mathrm{U}$ types for a given voltage and capacitance.

### 8.2.2.2.3.2 Tantalum

Solid tantalum capacitors have good temperature stability: a high-quality tantalum typically show a capacitance value that varies less than $10-15 \%$ across the full temperature range of $-40^{\circ} \mathrm{C}$ to $+125^{\circ} \mathrm{C}$. ESR varies only about $2 \times$ going from the high-to-low temperature limits.
The increasing ESR at lower temperatures can cause oscillations when marginal quality capacitors are used (if the ESR of the capacitor is near the upper limit of the stability range at room temperature).

### 8.2.2.3 RFI/EMI Susceptibility

Radio frequency interference (RFI) and electromagnetic interference (EMI) can degrade any integrated circuit's performance because of the small dimensions of the geometries inside the device. In applications where circuit sources are present which generate signals with significant high frequency energy content (>1 MHz), care must be taken to ensure that this does not affect the device regulator.
If RFI/EMI noise is present on the input side of the regulator (such as applications where the input source comes from the output of a switching regulator), good ceramic bypass capacitors must be used at the IN pin of the device.
If a load is connected to the device output which switches at high speed (such as a clock), the high-frequency current pulses required by the load must be supplied by the capacitors on the device output. Since the bandwidth of the regulator loop is less than 100 kHz , the control circuitry cannot respond to load changes above that frequency. This means the effective output impedance of the device at frequencies above 100 kHz is determined only by the output capacitors.
In applications where the load is switching at high speed, the output of the device may need RF isolation from the load. It is recommended that some inductance be placed between the output capacitor and the load, and good RF bypass capacitors be placed directly across the load.
PCB layout is also critical in high noise environments, since RFI/EMI is easily radiated directly into PC traces. Noisy circuitry should be isolated from clean circuits where possible, and grounded through a separate path. At MHz frequencies, ground planes begin to look inductive and RFI/ EMI can cause ground bounce across the ground plane. In multi-layer PCB applications, care should be taken in layout so that noisy power and ground planes do not radiate directly into adjacent layers which carry analog power and ground.

### 8.2.2.4 Output Noise

Noise is specified in two ways: Spot Noise or Output Noise Density is the RMS sum of all noise sources, measured at the regulator output, at a specific frequency (measured with a $1-\mathrm{Hz}$ bandwidth). This type of noise is usually plotted on a curve as a function of frequency. Total Output Noise or Broad-Band Noise is the RMS sum of spot noise over a specified bandwidth, usually several decades of frequencies.
Attention must be given to the units of measurement. Spot noise is measured in units $\mu \mathrm{V} / \sqrt{\mathrm{Hz}}$ or $\mathrm{nV} / \sqrt{\mathrm{Hz}}$ and total output noise is measured in $\mu \mathrm{V}_{\text {RMS }}$
The primary source of noise in low-dropout regulators is the internal reference. Noise can be reduced in two ways: by increasing the transistor area or by increasing the current drawn by the internal reference. Increasing the area decreases the chance of fitting the die into a smaller package. Increasing the current drawn by the internal reference increases the total supply current (GND pin current).

### 8.2.2.5 Power Dissipation

Knowing the device power dissipation and proper sizing of the thermal plane connected to the tab or pad is critical to ensuring reliable operation. Device power dissipation depends on input voltage, output voltage, and load conditions and can be calculated with Equation 2.

$$
\begin{equation*}
\mathrm{P}_{\mathrm{D}(\text { MAX })}=\left(\mathrm{V}_{\text {IN(MAX) }}-\mathrm{V}_{\text {OUT }}\right) \times \mathrm{I}_{\text {OUT }} \tag{2}
\end{equation*}
$$

Power dissipation can be minimized, and greater efficiency can be achieved, by using the lowest available voltage drop option that would still be greater than the dropout voltage ( $\mathrm{V}_{\mathrm{DO}}$ ). However, keep in mind that higher voltage drops result in better dynamic (that is, PSRR and transient) performance.

On the WSON (NGD) package, the primary conduction path for heat is through the exposed power pad to the PCB. To ensure the device does not overheat, connect the exposed pad, through thermal vias, to an internal ground plane with an appropriate amount of copper PCB area.
On the SOT-223 (NDC) package, the primary conduction path for heat is through the pins to the PCB.
Power dissipation and junction temperature are most often related by the junction-to-ambient thermal resistance ( $\mathrm{R}_{\theta \mathrm{JA}}$ ) of the combined PCB and device package and the temperature of the ambient air ( $\mathrm{T}_{\mathrm{A}}$ ), according to Equation 3 or Equation 4:

$$
\begin{align*}
& T_{J \text { (MAX) }}=T_{A(M A X)}+\left(R_{\text {ӨJA }} \times P_{D(\text { MAX })}\right)  \tag{3}\\
& P_{D}=T_{J \text { JMAX) }}-T_{\text {A(MAX) }} / R_{\text {ӨJA }} \tag{4}
\end{align*}
$$

Unfortunately, this $\mathrm{R}_{\theta \mathrm{JA}}$ is highly dependent on the heat-spreading capability of the particular PCB design, and therefore varies according to the total copper area, copper weight, and location of the planes. The $\mathrm{R}_{\text {өJA }}$ recorded in Thermal Information is determined by the specific EIA/JEDEC JESD51-7 standard for PCB and copperspreading area, and is to be used only as a relative measure of package thermal performance. For a welldesigned thermal layout, $\mathrm{R}_{\text {өJA }}$ is actually the sum of the package junction-to-case (bottom) thermal resistance ( $\mathrm{R}_{\text {өJCbot }}$ ) plus the thermal resistance contribution by the PCB copper area acting as a heat sink.

### 8.2.2.6 Estimating Junction Temperature

The EIA/JEDEC standard recommends the use of psi $(\Psi)$ thermal characteristics to estimate the junction temperatures of surface mount devices on a typical PCB board application. These characteristics are not true thermal resistance values, but rather package specific thermal characteristics that offer practical and relative means of estimating junction temperatures. These psi metrics are determined to be significantly independent of copper-spreading area. The key thermal characteristics ( $\Psi_{J T}$ and $\Psi_{\mathrm{JB}}$ ) are given in Thermal Information and are used in accordance with Equation 5 or Equation 6.

$$
\mathrm{T}_{\mathrm{J}(\mathrm{MAX})}=\mathrm{T}_{\mathrm{TOP}}+\left(\Psi_{\mathrm{JT}} \times \mathrm{P}_{\mathrm{D}(\mathrm{MAX})}\right)
$$

where

- $\mathrm{P}_{\mathrm{D} \text { (MAX) }}$ is explained in Equation 4
- $\mathrm{T}_{\text {Top }}$ is the temperature measured at the center-top of the device package.
$\mathrm{T}_{\mathrm{J} \text { (MAX) }}=\mathrm{T}_{\text {BOARD }}+\left(\Psi_{\mathrm{JB}} \times \mathrm{P}_{\mathrm{D}(\text { MAX })}\right)$
where
- $\mathrm{P}_{\mathrm{D} \text { (MAX) }}$ is explained in Equation 4.
- $\mathrm{T}_{\text {BOARD }}$ is the PCB surface temperature measured 1 -mm from the device package and centered on the package edge.

## 9 Power Supply Recommendations

The LP3869x-ADJ devices are designed to operate from an input supply voltage range of 2.7 V to 10 V . The input supply must be well regulated and free of spurious noise. To ensure that the LP3869x-ADJ output voltage is well regulated, the input supply must be at least $\mathrm{V}_{\text {OUT }}+0.5 \mathrm{~V}$, or 2.7 V , whichever is higher. A minimum capacitor value of $1-\mu \mathrm{F}$ is required to be within 1 cm of the IN pin.

## 10 Layout

### 10.1 Layout Guidelines

Good PC layout practices must be used or instability can be induced because of ground loops and voltage drops. The input and output capacitors must be directly connected to the IN, OUT, and GND pins of the regulator using traces which do not have other currents flowing in them (Kelvin connect).
The best way to do this is to lay out $\mathrm{C}_{\mathbb{N}}$ and $\mathrm{C}_{\text {OUt }}$ near the device with short traces to the IN, OUT, and GND pins. The regulator ground pin must be connected to the external circuit ground so that the regulator and its capacitors have a single point ground.
Stability problems have been seen in applications where vias to an internal ground plane were used at the ground points of the device and the input and output capacitors. This was caused by varying ground potentials at these nodes resulting from current flowing through the ground plane. Using a single point ground technique for the regulator and the regulator capacitors fix the problem. Because high current flows through the traces going into IN and coming from OUT, Kelvin connect the capacitor leads to these pins so there is no voltage drop in series with the input and output capacitors.

### 10.3 WSON Mounting

The NGG0006A (No Pullback) 6-lead WSON package requires specific mounting techniques which are detailed in AN-1187 Leadless Leadframe Package (LLP), SNOA401. The pad style which to use with the WSON package is the NSMD (non-solder mask defined) type. Additionally, TI recommends the PCB terminal pads to be 0.2 mm longer than the package pads to create a solder fillet to improve reliability and inspection.
The input current is split between two IN pins, 1 and 6 . The two IN pins must be connected together to ensure that the device can meet all specifications at the rated current.

The thermal dissipation of the WSON package is directly related to the printed circuit board construction and the amount of additional copper area connected to the DAP.
The DAP (exposed pad) on the bottom of the WSON package is connected to the die substrate with a conductive die attach adhesive. The DAP has no direct electrical (wire) connection to any of the pins. There is a parasitic PN junction between the die substrate and the device ground. As such, it is strongly recommend that the DAP be connected directly to the ground at device lead 2 (that is, GND). Alternately, but not recommended, the DAP may be left floating (that is, no electrical connection). The DAP must not be connected to any potential other than ground.
